ELIGIBILITY: All work must be totally conceived and recently executed by the artist and not previously shown at any WAL show. Artwork entered in this show should not have been done with the aid of an instructor (or in a class or workshop setting). Each artist is limited to two pieces of work. The media accepted into this show are oil, watercolor, acrylic, pastel, graphics, and mixed media (including collage). Entries need not be for sale (NFS). Portraits may show price of similar work (SIM).

Paintings must be ready for hanging with screw eyes or d-hangers and the wire must not extend above the top of frame. **NO SAW TOOTH** hangers will be accepted. Paintings, including frame must not exceed 44 inches in any direction.

ENTRY FEES: Members **\$20** for 2 entries, non-members **\$25** for two entries. Fees are not refundable.

ENTRY FORM: Each entry must have an entry form attached to upper left corner of back of the frame. Please complete all sections.

JUDGING: Artists whose work is not selected will be notified before the opening of the show. It will be the artist's responsibility to make arrangements when called to pick up non selected work.

SALES: A donation to WAL of 25% will be deducted from the purchase price of all sales.

PICK UP TIME: Saturday, May 12, - 10:30 AM – 12:30 PM.
No Storage is available; please mark your calendars for pick up time.

RESPONSIBILITY: The greatest care will be taken in handling works, but neither WAL, Inc. nor any of its agents, nor the Middlebury Library shall be responsible for any loss of or damage to any entry from any cause, whether such entry shall be on display, in storage or in transit.
