Artwork entered in this show should not have been done with the aid of an instructor (or in a class or workshop setting). Each artist is limited to two pieces of work. The media accepted into this show are oil, watercolor, acrylic, pastel, graphics, and mixed media (including collage). Entries need not be for sale (NFS). Portraits may show price of similar work (SIM).

Paintings must be ready for hanging with screw eyes or d-hangers and the wire must not extend above the top of frame. **NO SAW TOOTH** hangers will be accepted. Paintings, including frames must not exceed 44 inches in any direction.

**ENTRY FEES: Members \$25 for one or two entries, non-members \$30 for one or two entries. Fees are not refundable.**

**ENTRY FORM:** Each entry must have an entry form attached to upper left corner of back of the frame. Please complete all sections.

**JUDGING:** Artists whose work is not selected will be notified before the opening of the show. Non-accepted work can be picked up during show hours or at end of show, Sunday October 23, 4-5.

**PICK UP TIME for ACCEPTED WORK: Sunday, October 23, 4-5 PM**

**SALES:** A donation to WAL of 25% will be deducted from the purchase price of all sales.

**RESPONSIBILITY:** The greatest care will be taken in handling works, but neither WAL, Inc. nor any of its agents, nor the 550 Gallery and Studio shall be responsible for any loss of or damage to any entry from any cause, whether such entry shall be on display, in storage or in transit.
